# PAK AGRO OIL MILLS (PVT.) LTD.

Pak Agro Oil Mills (flagship company of Pak Agro Group) was established in 2006 and is one of the leading players among edible oil extraction companies in Pakistan. The Solvent plant has an existing crushing capacity of 800 MT per day. The plant produces edible oil and seed meal from imported oil seeds, such as Soybeans, Canola and Sunflower seeds. The oilseeds are primarily imported from the countries like USA, Brazil, Canada, and Australia through top grain suppliers i.e. Cargill, Louis Dreyfus, Vittera, Cofco, ADM, Olam, & Al Ghurair. The company also has a 100 TPD Cooking Oil refinery and a Banaspati hydrogenation plant to produce its own brands, Harpal and Goldflower.









# PAK PLASTI PACK INDUSTRIES (PVT.) LTD.

Pak Plasti Pack Industries is a Polypropylene Woven manufacturing Company that was established in 2014 equipped with the most modern high speed automatic machinery producing 120,000 bags per day.

The highly skilled staff is our strength in making value added products for export markets. The company also started producing BOPP laminated and FIBC bags, which are in great demand from the exporters of rice, cement, petrochemicals, and minerals.

The company is planning to double its production capacity to 240,000 bags per day to meet the growing demand.
